The well was shut-in in 1986 and currently has approved long term shut-in status. The well has recently tested 6 BOPD and 0 BWPD. The produced fluid from this well is sent via flowline to Test Station No. 13 located at SW SW Sec. 35-31N-16W and is transported with a hot oiler to Central Battery No. 1 for separation. The tank at Test Station No. 13 will be locked and sealed and seal records will be maintained. The well will be tested on a semi-annual basis.
