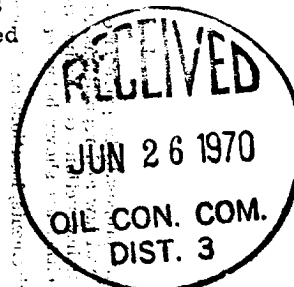

We propose to cease injection in this well as uneconomical to operate. The production supported by this well is not sufficient to justify continued injection. Part of the water normally injected in this well will be transferred to a well nearer the center of the field. Perforations open are 1447'-1478'. If any adverse effect on oil production is noted we will probably want to resume injection in this well.
