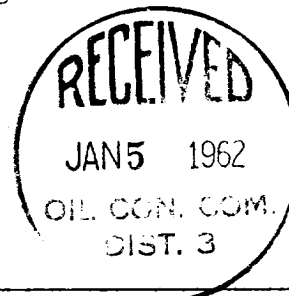

Drilled 7 7/8" hole to 6543'. Ran 5 1/2" 15.5# J-55 casing to 6543'. Cemented with 115 sx. 4% gel cement. Bumped plug with 200 PSI at 4:00 a.m. 11-20-61. Waited 8 hours, cement thru stage collar at 4519' with 165 sx. 50-50 Pozmix cement. Shut-in 1:45 p.m. 11-20-61.

11-25-61: Drilled out to 6524'. Pressure test casing to 200 PSI for ten minutes, held OK.
