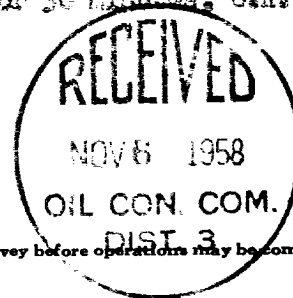

DETAILS OF WORK

This well was spudded 12:00 Noon 11-1-58. Drilled to 105' SW. Ran 3 joints 2-5/8" O.D. 2 1/2 J-55 casing = 94.07'. Set at 102.07' and cemented with 125 sacks common cement plus 3% CaCl. Plug down 4:00 P.M., 11-1-58. W.O.G. 19 hours. Nipped up BOP's. Tested casing with 600' for 30 minutes. O.K. Drilled plug at 8:00 A.M., 11-2-58.
