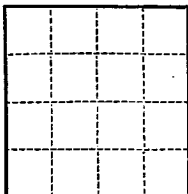

DETAILS OF WORK

This well was spudded at 3:00 P.M., 2-21-59. Drilled 12-1/4" hole to 102' SIM. Ran 3 joints of 8-5/8" O.D. 24" J-55 casing = 87.67'. Set at 95.70' and cemented with 115 sacks common cement plus 3% CaCl. Job complete 12:30 A.M., 2-22-59. W.O.C. 14 hours, released pressure and nipped up BOP's. Tested casing with 550# for 30 minutes, O.K. Started drilling plug at 4:30 P.M., 2-22-59.

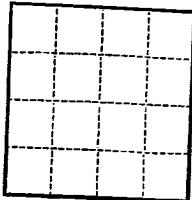

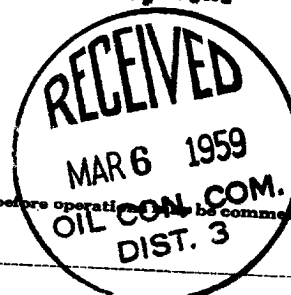

Drilled to 1419' TD. Ran Schlumberger SP Sonic and Induction ES logs, their T.D. 1419'. Ran 47 joints of 4-1/2" O.D. 9.5# J-55 casing = 1402.62'. Set at 1409.82' and cemented with 160 sacks regular mix Pozmix. Plug down at 12:30 P.M., 2-25-59. Ran 4 Baker centralizers. W.O.C. to 11:00 A.M., 2-26-59. Released pressure and nipple up BOP's. Tested 4-1/2" casing with 1000# for 30 minutes, O.K.
