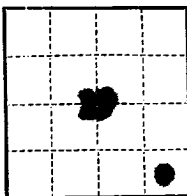

Get Powell downright took at 11:15 PM and lasted for 30 min. using 20/40 sand and water. Get complete at 11:45 P.M., 1-25-41. Set Baker No. 200 Russian Packer at 11:50. Powell moved through much at 11:51, formation broke down & stopped in at 11:55. About 1-200 checked & pressure dropped to 2100. Pumped 2000 gal. water containing 2000 20/40 sand plus 100 Powell 1-200 when developed communi- cation between casing & tubing. Ave. temp. just in 11:52, ave. press. 2100, fluid press. 1100. Get complete 1:00 P.M., 1-25-41. Screen tubing and packer and get packer at 1:05 PM. Now injecting into both upper and lower casing formation through casing well hole.
