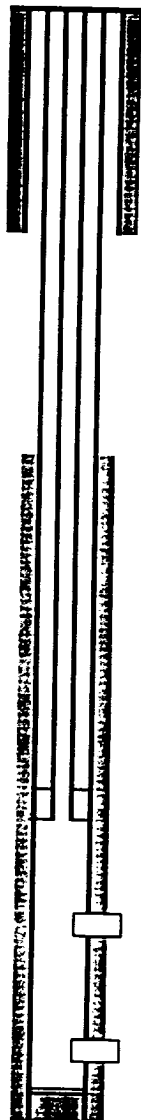

History:

Prior to conversion there were three pulling jobs for minor equipment failures; paraffin was noted on the reports. After conversion the well was acidized in 1967. There were few pulling jobs after that until the well was SI in 1986; paraffin was noted again on some reports.

Cumulative production was 29,813 BO. As of 12/31/77 cumulative injection was 1,590,003 BW and as of 7/31/86 it was 1,851,196. There are no indications that the well was SI prior to 1986.

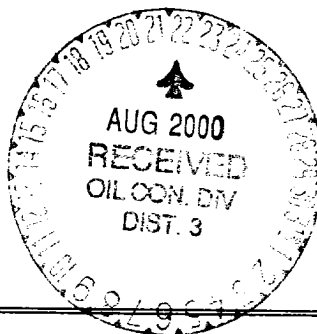
