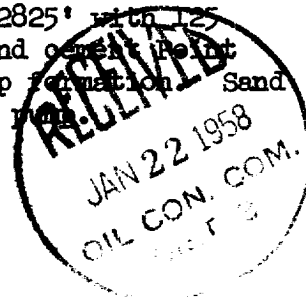

DETAILS OF WORK

We propose to: Set 100' 9-5/8" casing at 100' with 100 sacks. Drill to approximately 2825'. Set 5 1/2" casing at 2825' with 125 sacks, run DV tool below Point Lookout and cement Point Lookout with 200 sacks. Perforate Gallup formation. Sand oil frac. Run 2-3/8" tubing and install pump.

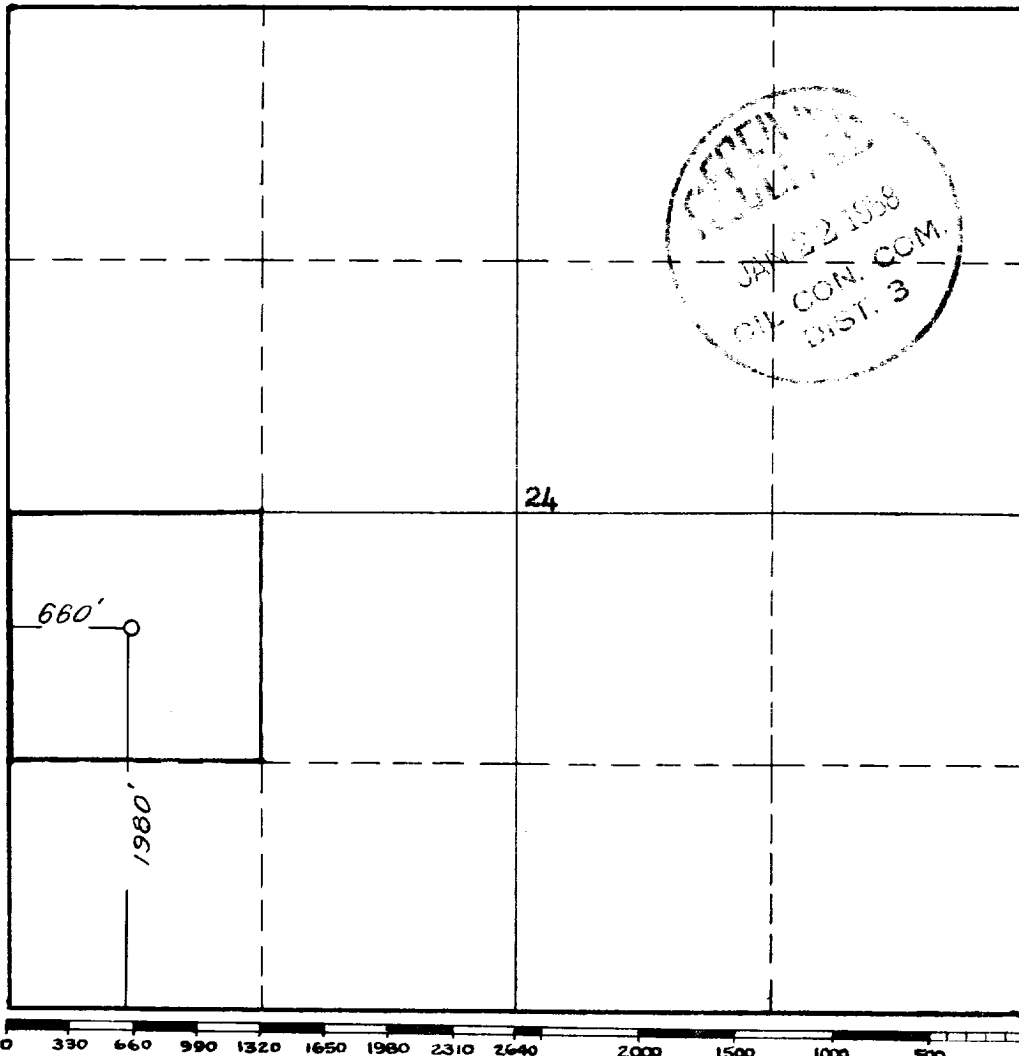
