

DETAILS OF WORK

This well was spudded 4:30 P.M., 3-12-59. Drilled 12-1/4" hole to 105' SH. Ran 3 joints 8-5/8" O.D. 2 1/4# J-55 casing = 89.45'. Set at 97.47' and cemented with 115 sacks common cement plus 3% CaCl. Job complete 12:30 A.M., 3-13-59. Cement circulated. W.O.C. to 2:00 P.M., 3-13-59. Released pressure, nipped up BOP's. Tested 8-5/8" casing with 550# for 30 minutes, O.K. Started drilling plug at 5:30 P.M., 3-13-59.
