Spot cement plug in Gallup open hole from 2613' to 2913' and continue up inside 4 1/2" casing to 2473'. Shoot off 4 1/2" casing to 1400'. Spot 100' cement plug across shooting point. Spot cement plug across top of Point Lookout Formation from 850' to 950'. Spot 50' of cement across bottom of surface casing, spot 10 ex. in top of surface and erect dry hole marker.

Instructions
