A blind plate will be installed at the surface to prevent gas sales. All production equipment associated with the Blanco Mesaverde will be dismantled. Amoco plans to use the Mudge B #14 as a pressure monitor well for the Blanco Mesaverde. From this point forward, the Mudge B #17 will be dually produced as a Basin Dakota and a Blanco Mesaverde.
