On 8-23-65 ran 54 jts. 4 1/2" OD 9.5# J55 casing 1717.99' set @ 1723' RKB. Cemented w/ 50 sacks class A cement 12.5# Gilsontite 1 1/2 Halide 9. Displaced plug w/150 gal. 10% MSA followed w/oil plug. Plug on bottom 1:15 PM 8-23-65. Perf. 4 shots/ft 1572-76 and 1580-82. Sand oil prec. 15,000# 20-40 sand, 10,000# 10-20 sand and 26,280 gal. oil. Break down press 1800#, max Press. 2600#, min. press. 1500#, ave. press. 1700#. Dropped 18 rubber balls in 3 stages. Instant SI. press. 100#. Ran tubing and rods on 9-4-65. Pumping EO on 9-10-65 will file completion report after EO is recovered.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
