ARCO Oil and Gas Company respectfully requests approval for extension of long term shut-in status on this well. At this time, under the current waterflood operation, ARCO cannot economically operate the subject well. An ongoing study to determine the feasibility of CO<sub>2</sub> flooding for the Horseshoe Gallup Field is underway, which may yield significant additional oil recovery (a CO<sub>2</sub> Pilot Project is planned to begin later this year as part of the study to assess CO<sub>2</sub> flooding potential). Implementation of a CO<sub>2</sub> flood would require the workover of existing wells, and the drilling of new wells. For this reason, ARCO proposes that this well be maintained in the long term shut-in status so that the wellbore will be available, should it be needed as part of a future CO<sub>2</sub> flood. This plan eliminates the economic waste of potentially usable wellbores, and promotes conservation.
