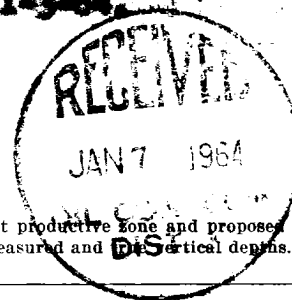

Instructions

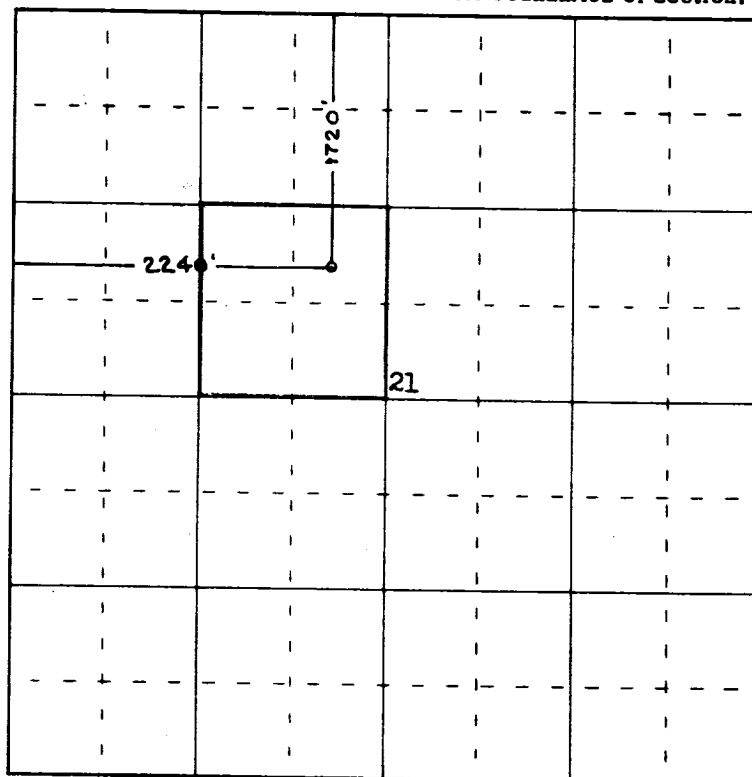
