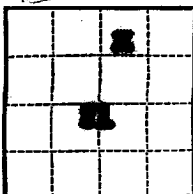

DETAILS OF WORK

Rotary drilling equipment will be used to drill to approximately 730' to the San Juan Formation. If production is found, casing will be set and cemented with required amount of cement. Native mud and water will be used in drilling. Shows will be tested and electric logs will be run prior to setting casing or abandonment. Stimulation treatments may be employed in completion.

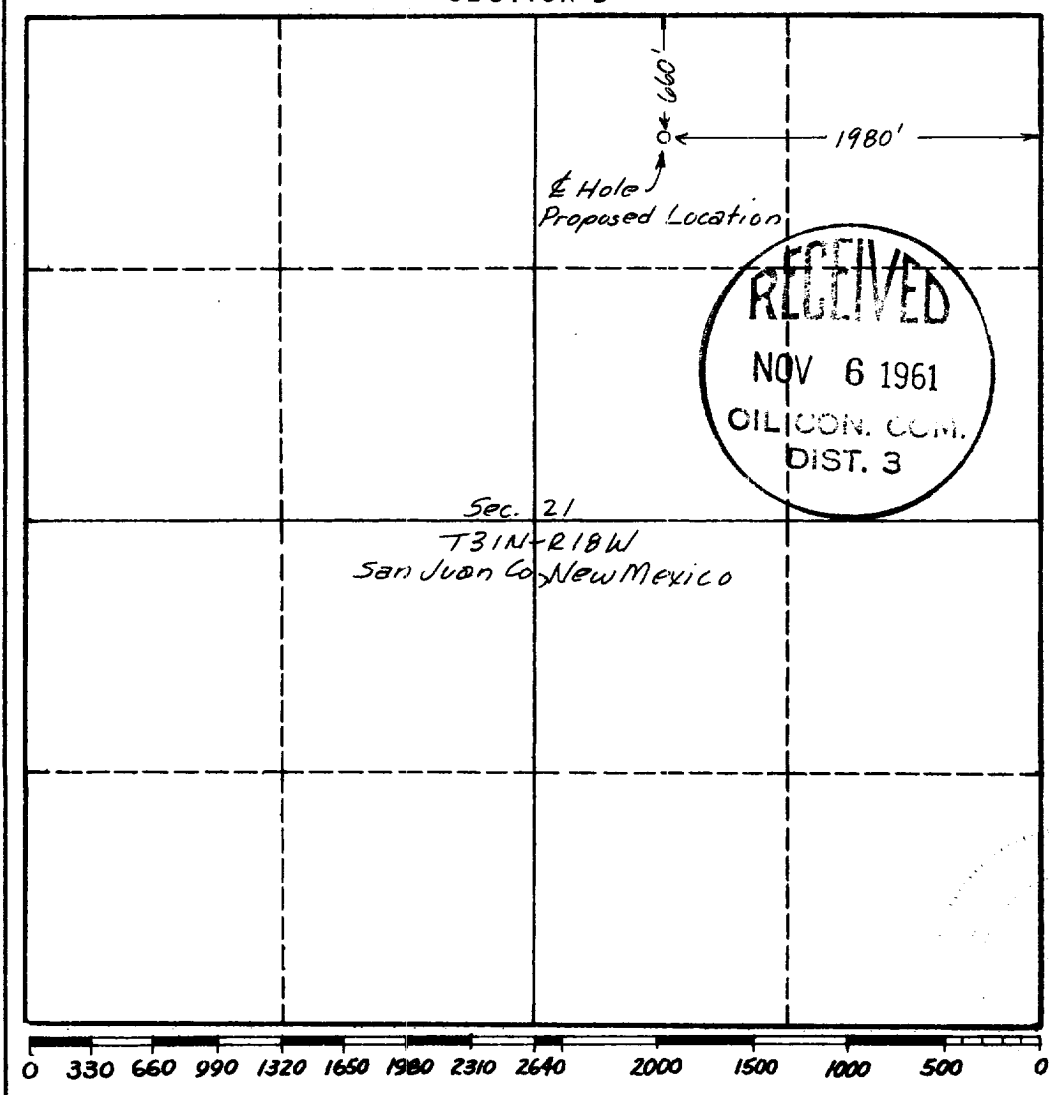
