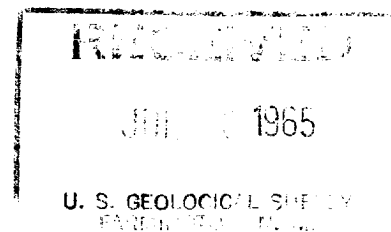
It is planned to perform the following work in order to improve the mechanical condition of the well and increase its productivity.

Pull tubing and clean out the existing hole or squeeze the open hole w/cement and drill a new side-tracked hole through the Mesa Verde.

Test the 7" casing and squeeze any leaks w/cement or perforate the 7" opposite the base of the Ojo Alamo and squeeze the 7" annulus w/cement.

Run and cement a string of 4 1/2" production casing, perforate the Mesa Verde pay and sand-water fracture.

Clean out the well and run tubing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
