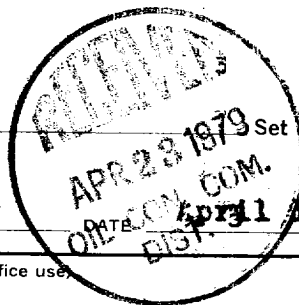
Spot cement plug across Gallup perforations from 1991' to 1886' and continue up 4½" casing to 1836'. Shoot off 4½" casing to 1425'. Spot 50' plug across shooting point. Spot 100' plug from 230' to 330' across top of Point Lookout. Spot 50' plug across bottom of surface. Spot 10 sacks of cement in top of hole and erect a dry hole marker.

Instructions

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
