## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On January 1, 1955, the Point Lookout Formation was sandoil fraced with 8000 gallons diesel oil and 9500 pounds sand. Formation broke at 450 pounds, injection pressure 700 pounds at an injection rate of 19.2 barrels per minute. Potential test after treatment was 3150 MEFPD.
