

DETAILS OF WORK

It is proposed to pull casing and plug the subject well. A 30-neck plug will be set covering the open hole and approximately 30' of casing. A 30-neck plug will be set covering the stub on the out-off portion of the pipe. A 15-neck plug will be set covering the end of the surface casing. A 5-neck plug will be set on surface for a monument. In the event we are unable to pull any casing the casing will be filled with sand from the bottom plug to the surface plug. Cement will be pumped down the annulus between the surface pipe and production pipe to prevent surface water encroachment.

The production on this well is now 0.

I understand that this plan of work must receive approval in writing by the Geological Survey before operation may be commenced.
