On 10-19-70 cut off stuck tubing at 4270', pulled tubing and set cement retainer at 4056'. Squeezed open hole w/150 sacks of cement.

On 10-20-70 Perf one squeeze hole at 1830', set cement retainer at 1780', squeezed perf. w/225 sks. cement.

On 10-23-70 T. D. 5201'. Ran kz 161 joints 4 1/2", 10.5#, K-55 production casing (5189') set at 5201' w/125 sacks of cement. W. O. C. 18 hours.

On 10-24-70 P. B. T. D. 5191'. Perf. 5052-60', 5072-76', 5118-26', 5148-56' w/16 SPZ. Frac w/36,000# 20/40 sand, 38,850 gal. water, dropped 3 sets of 16 balls, flushed w/6384 gal. water. Dropped ball to baffle at 5028', tested to 3000 psi O. K. Perf. 4858-70', 4880-92', 4906-14', 4924-30', 4940-46', 4970-74', 4992-96' w/16 SPZ. Frac w/71,000# 20/40 sand, 71,442 gal. water, dropped 5 sets of 16 balls and 1 set of 32, flushed w/3570 gal. water. Set bridge plug at 4400', tested to 4000# O. K. Perf. 4184-90', 4222-32', 4262-72', 4322-34', 4344-56' w/18 SPZ. Frac w/52,000# 20/40 sand, 52,164 gal. water, dropped 4 sets of 18 balls, flushed w/3150 gal. water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
