Dear Mr. Kiel:

On February 13, 2002, New Mexico Oil Conservation Division (OCD) Deputy Inspector, Bruce Martin, found that the referenced well was in violation of OCD Order SWD 785.

An OCD investigation determined the following:

1. The gauge at the well indicated an injection pressure of 830 psi in violation of the maximum allowable injection pressure of 608 psi.
2. The pressure limiting device on the injection pump had been set to 3000 psi, in violation of Order SWD 785.
3. The pressure limiting device on the injection pump was disconnected in violation of Order SWD 785.
4. Pressures reported on C115's through the month of December 2001 indicate an injection pressure of 250 psi.

Any further violation may result in Texakoma Oil & Gas Corp. being summoned to a show cause hearing before a Division Hearing Examiner where the Division staff will recommend issuance of a formal order requiring compliance with OCD rules. Such an order may include imposition of civil penalties
