ORDER NO. MC-1132

THE APPLICATION OF EL PASO NATURAL GAS COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS MUDGE WELL NO. 11 LOCATED IN THE SW/4 SW/4 OF SECTION 10, TOWNSHIP 31 NORTH, RANGE 11 WEST, NMPM, SAN JUAN COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PERMIT THE PRODUCTION OF GAS FROM THE BLANCO-MESAVERDE POOL AND THE PRODUCTION OF GAS FROM THE BASIN-DAKOTA POOL.



Under the provisions of Rule 112-A (II) El Paso Natural Gas Company made application to the New Mexico Oil Conservation Commission on December 7, 1961, for permission to dually complete its Mudge Well No. 11 located in the SW/4 SW/4 of Section 10, Township 31 North, Range 11 West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Blanco-Mesaverde Pool and the production of gas from the Basin-Dakota Pool.

Now, on this 26th day of December, 1961, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Subsection II of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, El Paso Natural Gas Company, be and the same is hereby authorized to dually complete its Mudge Well No. 11 located in the SW/4 SW/4 of Section 10, Township 31 North, Range 11 West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Blanco-Mesaverde Pool and the production of gas from the Basin-Dakota Pool through parallel strings of tubing.

PROVIDED HOWEVER, That applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 112-A.
