In support of this application, Aztec Oil & Gas Company respectfully states and shows the following:

- l. Applicant's well, which is in the shallow oil producing area southwest of Barker Dome gas field, will be located one thousand two hundred and sixty-eight (1,268) feet from the East line and nine hundred and nineteen (919) feet from the South line of Section 10, Township 31 North, Range 15 West, M.M.P.M., San Juan County, New Mexico. This non-standard location was selected because of topographical conditions existing on the drilling block.
- 2. The non-standard location of Applicant's well is necessitated by the extreme topographical conditions in the area which prevented a standard location.
- 3. Attention is called to the fact that Aztec and Southern Union Cas Company jointly own Sections 10 and 15 of Township 31 North, Range 15 West, and that the location is 1,268 feet West of Section 11, held by Matural Cas Company and/or Claude Carroll.
