Set cement across shooting point to 1750'. Set 100' plug from 450' to 550' across top of Point Lookout. Spot 50' plug across bottom of surface. Spot 10 sacks cement in top of hole and erect dry hole marker.**

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
