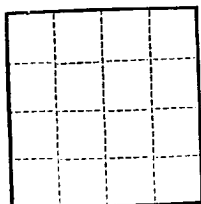

DETAILS OF WORK

We propose to drill w/rotary tools using mud to base of Pictured Cliffs, set intermediate string and drill w/gas to base of Dakota set production string. Perforate and fracture for gas completion in the Dakota.

Proposed Casing Program:

Approx. 250' - 10-3/4" 32.75# H-40 SS casing - cemented ID to surface.
" 3000' - 7-5/8" 26.40# J-55 SS casing - cemented w/200 sx.
" 7500' - 5-1/2" 17# J-55 SS casing - cemented w/250 sx.
" 7500' - 2" EUE tubing.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

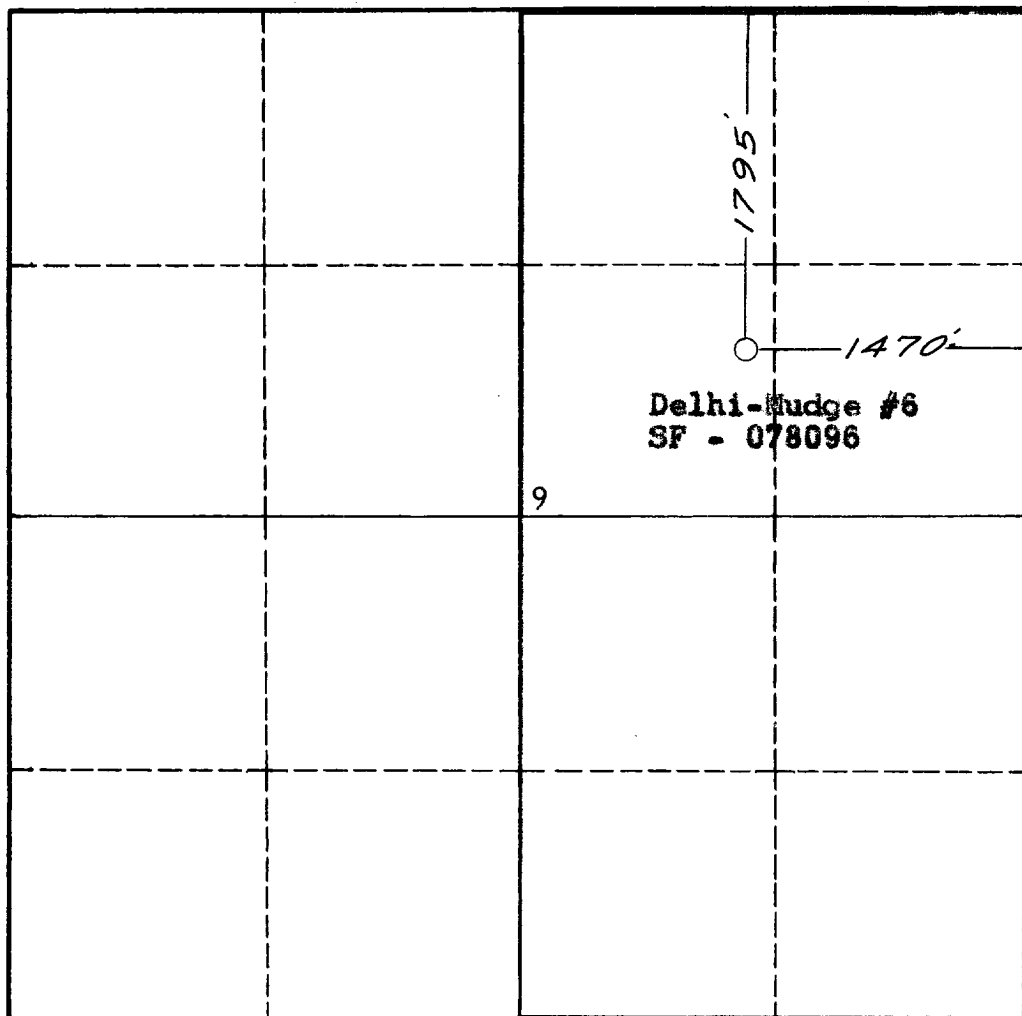
