This Upper and Lower Zones Gallup well has declined about 50% in production. We propose to sand oil fracture both zones in an effort to restore production. About 18,000 gal of 20/40 sand in about 18,000 gal of lease crude will be used with ball sealers to separate zones. Perforations open are 1209'-1216' and 1326'-1336'.
