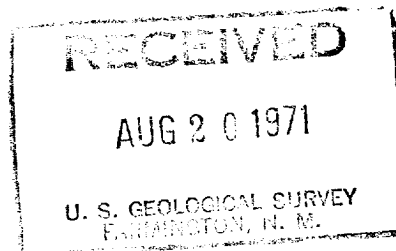

The 5 1/2" casing in this well is perforated 1209'-1216' (Upper Gallup) and 1326'-1336' (Lower Gallup). Present production is 5 BOPD & 12 SCFD.

We propose to convert this well to water injection as part of the Many Rocks Gallup Project. A small acid cleanup will probably be necessary. A Baker tension type packer will be set at about 1275' and water injected into the Lower Gallup through 2 3/8" O.D. tubing and into the Upper Gallup down 5 1/2" x 2 3/8" annulus.

Instructions
