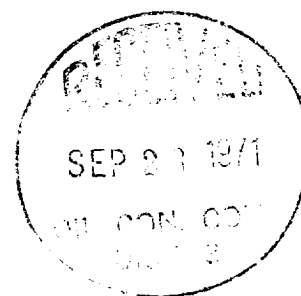
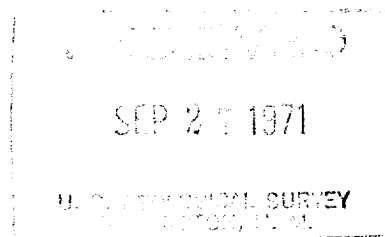

On 9/12/71 - Ran Baker Model - packer on 2 3/8" O.D. tubing and set at 1276'. Treated each zone w/500 gal. 15% Hcl containing 27 1/2 gal. Jet Service 6152. Upper zone pressure 600 to 450 psi. Lower zone pressure 500 to 400 psi.

On 9/17/71 - Finished connecting lines and started injecting water into Upper Gallup (1209'-1216') down 5 1/2" x 2" annulus and into Lower Gallup (1326'-1336') down 2 3/8" O.D. tubing.

Instructions
