DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The well was spudded at 8:40 P.M., July 24, 1953. On July 26, 1953, 9-5/8" casing was landed at 280 feet and cemented with 300 sacks of cement. Cement plug down at 11:55 A.M., July 26, 1953. At 11:55 P.M., July 27, 1953, casing and water shut-off were tested at 500 pounds for 30 minutes with no drop in pressure. Forty-six feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 500 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.
