DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The well was spudded at 7:45 A.M., September 11, 1953. On September 12, 1953, 9-5/8" casing was landed at 261 feet and cemented with 250 sacks of cement. Cement plug down at 12:51 P.M., September 12, 1953. At 1:00 A.M., September 14, 1953, casing and water shut-off were tested at 500 pounds for 30 minutes, with no drop in pressure. Forty-four feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 500 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.

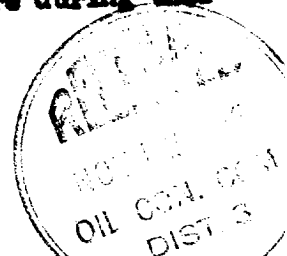
