August 16, 1985: Moved on location and rigged up. Pulled tubing.

August 19, 1985: Spotted a 120 sx (141.6 cu. ft.) cement plug to cover from 4510' to 5270'.

August 20, 1985: Tagged top of cement at 4033'. Mixed mud and circulated the wellbore. Spotted a 75 sx (88.5 cu. ft.) cement plug from 2370' to 2940' to cover the Fruitland and the top of Pictured Cliffs formation. Perforated 4 squeeze holes at 1190'. Spotted a 35 (41.3 cu. ft.) cement plug. Pressure displace 20 sx into the squeeze holes. Leaving a 100' cement plug inside and outside the casing from 1090' to 1190' to cover the top of the Ojo Alamo formation.

August 21, 1985: Tagged top of cement at 1105. Perforated 4 squeeze holes at 188'. Could not break down perforation at 1000' psig. Perforated second set of 4 squeeze holes at 150'. Circulated a 50 sx (59 cu. ft.) cement plug back to surface. Cut off wellhead and installed dry hole marker with 5 sx (5.9 cu. ft.) cement plug.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
