POOH with 1-1/4" tubing. Set CIBP at +/- 5700' to permanently abandon Mesaverde. Spot 50' cement on top of CIBP. Pressure test casing. Perforate Pictured Cliffs from 3435'-3620'OA. Breakdown perfs with PIP tool. Fracture stimulate Pictured Cliffs. Flowback to clean up. Rerun 1-1/2" production tubing.
