Ran 57 joints of 5½" O.D. J-55 15.5# Liner (1705') set at 4535' with 100 sacks regular cement. Top of cement 4200'. Squeezed with 100 sacks of regular cement with Yowell tool at 2760'. Maximum pressure 2250#. Held 1500# on test.
