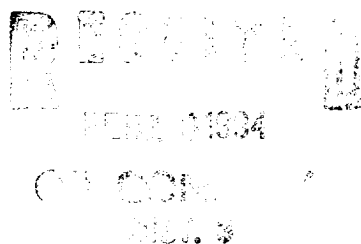

SPECIFIC INSTRUCTIONS
