DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to a total depth of 5110 feet with rotary tools. Shot formation from 4710 to 5110 feet open with 1860 quarts Hercules slow detonating explosive. Well was cleaned out to total depth with gas and 2" tubing landed at 5373 feet. Well shut in 4 days. Shut in casing pressure 1076 psi. After 6 hour blow down well measured 59 1/4 MCF per 24 hours through 1" outlet with side static gauge, June 29, 1953.
