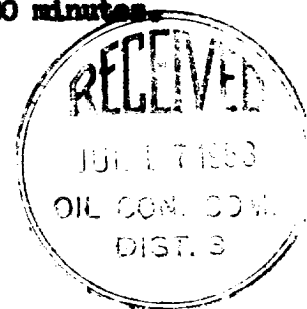

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On June 17, 1953, 7" casing was landed at 4646 feet and cemented with 410 sacks of cement. Plug down at 11:00 P.M., June 17, 1953. At 11:00 P.M., June 19, 1953, casing and water shut-off were tested at 1250 pounds pump pressure for 30 minutes. No drop in pressure. Forty-three feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 1250 pounds for 30 minutes. No drop in pressure. Drilling operations were resumed.
