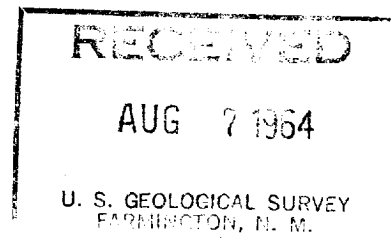

On 7-29-64 set fullbore packer at 606', pumped in at 2000#, bled back to 250#. Set packer at 819', held 2000# pressure. Perforated 4 holes at 685', gauged 5466 MCF/D after blowing through squeeze holes for 1 hour. Broke circulation through bradenhead. Set packer at 606', squeezed w/100 sacks 50/50 Pozmix, 2% calcium chloride, 300# pressure, released packer. Well making some amount of gas. Re-set packer at 606'. Squeezed w/200 sacks regular cement, 2% calcium chloride, standing pressure 650#. W.O.C. 12 hours. Released packer, squeeze job holding.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
