DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to a total depth of 5300 feet with rotary tools. Shot formation from 4610 to 5300 feet open with 200# quarts Hercules slow detonating explosive. Well was cleaned out to total depth with gas and 2" tubing was landed at 5231 feet. Well shut-in 8 days. Shut-in casing pressure 973 psi. Three hour potential test 1665 MPPL, July 6, 1954.
