On 8-21-64 ran Baker casing scraper and bit inside 4 1/2" casing. Scraper stopped at 4949'. Ran Bowen casing roller, swedged casing from 4943' to 4948'. Set RITE packer at 4693'. Pumped in 1 1/2 BPM @ 2000#. Squeezed w/100 sks. regular cement, 2% calcium chloride with no squeeze pressure. Set three hours, re-squeezed w/50 sacks regular cement, 2% calcium chloride, staged to 3000#.
