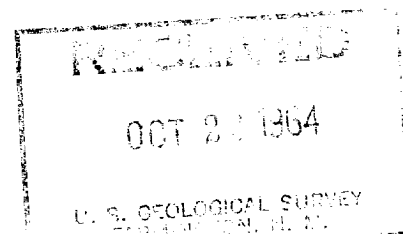
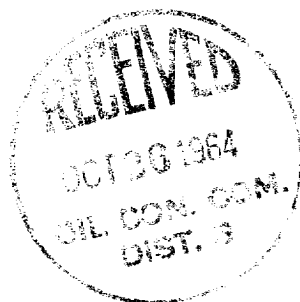

This is additional information on the 4 1/2" casing cement job:

On 8-17-64 the second stage cement job came up 1384' from the IV collar to 1830' by temperature survey. By calculation 35 cu. ft. of this slurry went outside of the 7" casing through corrosion holes which possibly existed at 2760', 2830', 2910', 2950', or 2980'. The top of the Fruitland is at 2759', and the top of the Pictured Cliffs is at 3178'.

Instructions
