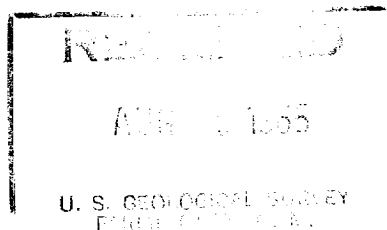

Max. pr. 3500#, BDP 2200#, tr. pr. 3100#. Dropped 3 sets of 16 balls each, flushed w/4000 gallons. I.R. 68 BPM. ISIP vacuum. Set GO magnesium bridge plug at 4950'. Perforated Cliff House 4810-18' w/2 SPF; 4848-52', 4872-76' w/4 SPF, fraced w/30,000# 20/40 sand and 30,000 gallons water w/1 1/2# FR-2/1000 gallons. Max. pr. 3500#, BDP 2100#, tr. pr. 1400-2000-2700#. Flushed w/4000 gallons. I.R. 43 BPM. Dropped 2 sets of 16 balls each. ISIP vacuum.

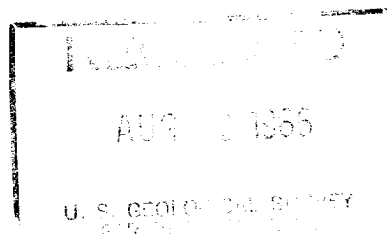

On 8-1-65 total depth 5377', ran 165 joints 4 1/2", 10.5#, J-55 casing (5366.05') set at 5376.05' w/150 sacks class "A" cement, 1/4 cu. ft. fine Gilsomite/sk., 2% gel.
