Proposed to plug back well as follows:

1. Pull 2" J.L.S. tubing from hole.
2. Set 7" casing cement retained at approx. 4800 ft. and squeeze off open shot hole from 197 ft. to 5000 ft. with 250 sacks cement.
3. Run casing, circulation log.
4. Set 7" casing whipstock at approximately 4875 ft. and cut window in 7" casing.
5. Drill 6-1/2" steel cased hole with gas to total depth of 5000 ft. J.L.S.
6. Run 4-1/2", 10.5 lb., 8-15 casing as a liner or full at the depending upon condition of 7" casing.
7. Cement 250 sacks to stimulate production.
8. Run out to J.L.S.
9. Run 2" J.L.S., 8-15 tubing, and at approx. 4800 ft. J.L.S.

Instructions
