DETAILS OF WORK

It is intended to drill & dual complete a well in the Dakota formation & Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs & set intermediate casing. Gas circulation will be used thru the middle of the Greenhorn formation & 7" liner will be set. Mud circulation will be used thru the Dakota formation & production liner will be set. Possible productive intervals will be perforated & fractured. Est. T.D. 8675'.

Casing Program:

- 13 3/8" at 300' with 600 sacks cement circulated to surface.
- 9 5/8" at 3900' with 900 sacks cement in two stages.
- 7" at 8379' with 600 sacks cement.
- 5" at 8675' with 100 sacks cement.

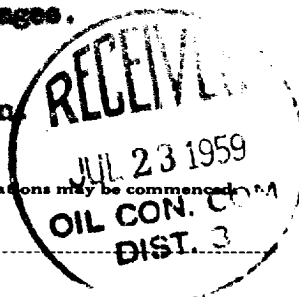
