Sting out of cmt retainer & spot 1 bbl cmt on top of cmt ret @ 3297'. TOOH w/2-3/8" tbg. Perf 2 0.50" diameter sqz holes @ 2195'. Shut-in well. SDON.

(7/10/02) TIH w/cmt retainer, set @ 2145'. Pump 139 sx Type II cmt, in sqz holes @ 2195'. Spot 1 bbl cmt on top of cmt ret @ 2145'. TOOH. Attempt to pump into bradenhead. Press up to 600 psi, leaked off. Unable to pump into bradenhead. TIH w/2-3/8" tbg open ended to 222'. Pump 42 sxs Type III cmt & spot 222' balanced cmt plug @ 222' to surface. TOOH w/2-3/8" tbg. ND BOP. Top fill csg w/0.3 bbl Type III cmt. Dig out bradenhead & cut off. Weld on 10.75" plate w/4.5" x 7" P&A marker. RD. Rig released. (Leo George, BLM, was on location).
