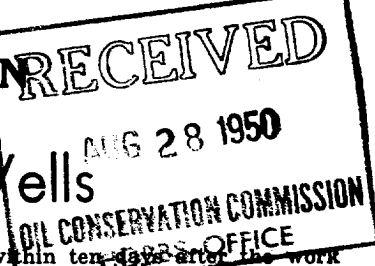

3545' - Total Depth - Shale. Temperature Survey - Top of cement on outside of 10-3/4" casing 2110'. Checked top of cement at 3477' and tested 10-3/4" casing & connections with 900# for 1/2 hour - no pressure drop. Drilled cement from 3477' to 3545' and tested casing & connections with 800# for 1/2 hour - no pressure drop. Started drilling formation and 9" hole at 12:30 A.M., August 17, 1950.
