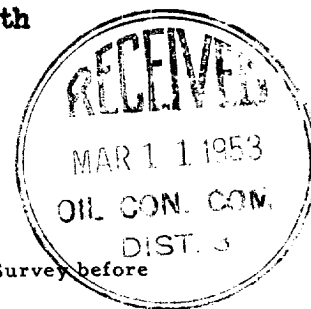

DETAILS OF WORK

Rotary depth 4798 feet. 5 1/2" casing was cemented at 4798' with 225 sacks, September 9, 1952. Cement plug was drilled February 10, 1953; hole swabbed dry. Tested for 2 hours with 500# pressure, pipe OK
