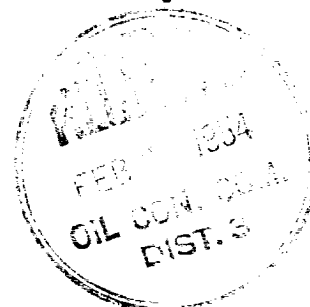

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

9-5/8" casing was set @ 194' (RTM) with 150 sacks of cement by the pump and plug method January 30, 1954. The cement circulated.

After 24 hrs the shoe was drilled and the casing was tested with 500 psi for 30 minutes. The test was satisfactory.
