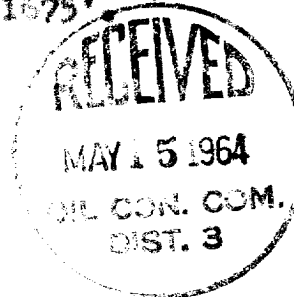

We propose to drill this well for water injection into the Upper and Lower Gallup formations as part of the Many Rocks Gallup project. Water will be injected thru tubing into the Lower Gallup and thru casing tubing annulus into the Upper Gallup. The Upper and Lower Gallup zones will be separated by a tension type packer. Estimated Upper Gallup top is 1540' and Lower Gallup top is 1675'.

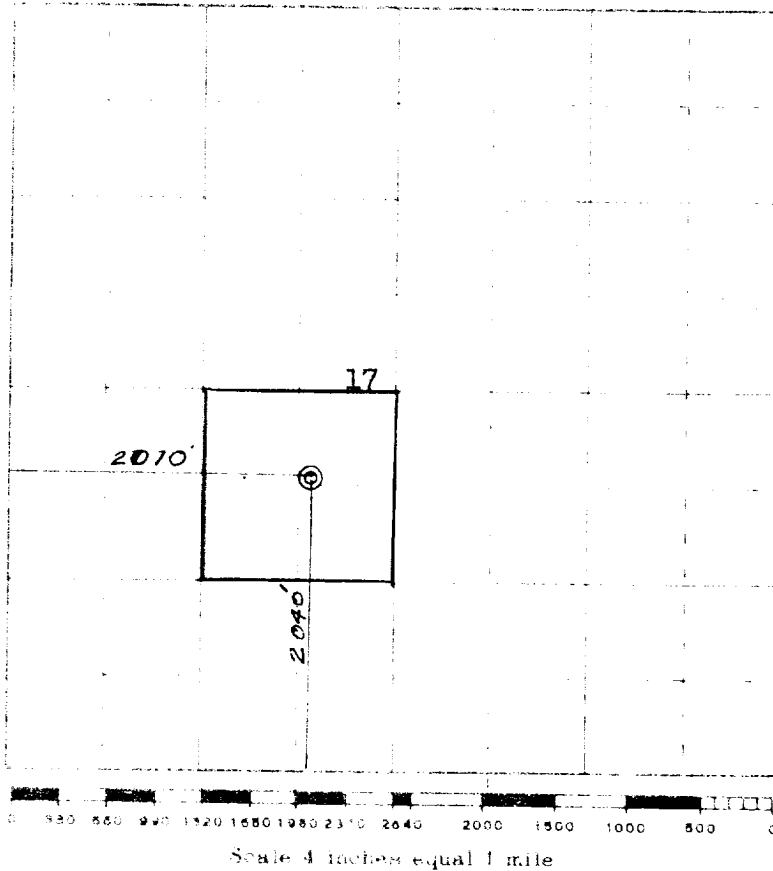
