We have received a copy of Oil Conservation Commission Form C- 101, Intention to Drill, which is for a Basin Dakota well together with a copy of Oil Conservation Commission form C-128.

This C-128 states that the Operator is the only owner of the N/2 of Sec. 16, T-31N, R-13 W. Our records indicate that we have various State Leases and Lessees in the N/2 of this section and to dedicate the N/2 to a Dakota well you will have to communitize this acreage.
