This is presently a small producing Dakota gas well. It is intended to set a bridge plug above the Dakota formation and perforate the Gallup zone from approximately 5900 ft. to 6100 ft. and attempt a recompletion.

If completion is successful, a 50 ft. cement plug will be placed on the bridge plug above the Dakota at a later date.
